Terms and Conditions

Eligibility and Registration Requirements

1. You must be of legal age to qualify for membership in the Program.
2. The person making the referral is called the "Referrer." As the Referrer, you must have an account in good standing with SouthEast.
3. The "Referee" is the customer who has been referred. As a referee, customer must be in good standing with SouthEast!
4. Current SouthEast customers are eligible to participate in the Program and make referrals to their friends and family.
5. Only new referrals made by registered members of the Program are eligible to earn rewards. Registered members include current customers of SouthEast, employees of SouthEast and employees of SouthEast Authorized Agents.
