1.0 Organiser

1.1 Setel Ventures Sdn. Bhd. ("Setel") is the organiser of this "11.11 WIN WIN Challenge".

2.0 Eligibility

- 2.1 This Contest is open to all Setel Application ("App") users aged eighteen (18) and above and is currently residing in Malaysia subject to the following Terms and Conditions ("Eligible Participant(s) and/or Participant(s)").
- 2.2 This Contest is open to all Eligible Participant(s), except for the following category of persons who are NOT ELIGIBLE to participate in the Contest:
 - (a) Permanent/Contract/Temporary employees of Setel;
