



## **'Belanja & Fuel Good' (MYDIN x Setel)**

**From 17 August, (12:00am) to 17 October 2023, (11:59pm)**

### **Terms & Conditions**

#### **1.0 Organiser:**

'Belanja & Fuel Good' ("Campaign") is organised by Mydin Mohamed Holdings Bhd (MYDIN) and Setel Ventures Sdn Bhd (Setel) ("Organiser"). will commence from 17<sup>th</sup> August 2023, 12:00 AM GMT+8) to 17<sup>th</sup> October 2023 23:59 AM (GMT+8) ("Campaign Period").

#### **2.0 Eligibility:**

1. This Campaign is only open to Setel users in Malaysia only.
2. Customers are able to download Setel through Google Play Store/ Huawei Store/ Apple App Store and must have a registered Setel account.
3. During the Campaign Period, each customer (1 user ID) is eligible to for RM6.60 Setel e-Voucher with a minimum spend of RM120 at Mydin branches nationwide (limited to 10,000 first transactions) and RM6.60 MYDIN e-Voucher for each RM50 fuel transaction at PETRONAS (limited to 10,000 first transactions) using Setel.
4. The MYDIN e-Voucher and Setel e-Voucher are only valid from 17<sup>th</sup> August 2023, 00:00 (GMT +8) to 17<sup>th</sup> November 2023 23:59 (GMT +8).
5. Vouchers can only be redeemed once per user for each Setel e-Voucher and MYDIN e-Voucher during the campaign period.

#### **3.0 Campaign Period**

Unless otherwise notified by the Organiser, the Campaign will be conducted from 17<sup>th</sup> August 2023, 12:00 AM (GMT+8) to 17<sup>th</sup> October 2023 23:59 AM (GMT+8) ("Campaign Period"), both dates inclusive.



#### 4.0 Campaign Mechanics

In order to join this Campaign, the customer is required to register/login to his/her Setel and complete either of the following steps within the Campaign Period as set out below.

1. Purchase minimum RM120 at MYDIN using Setel in a single receipt and receive RM6.60 Setel e-Voucher.
  - a. Customer purchase any of participating brands products\*
  - b. MYDIN POS recognize SKU of participating brands and the total receipt is more than RM120
  - c. Setel e-Voucher will be printed on the receipt stub
  - d. Customer to redeem Setel e-Voucher in Setel apps by entering the code printed on stub (in Setel apps, go to Pay > Top up > Voucher Top up > key in the e-Voucher code)
  - e. RM6.60 e-Voucher will be credited to Setel Wallet
2. Purchase minimum RM50 of fuel using Setel and receive RM6.60 MYDIN e-Voucher.
  - a. Customer purchase fuel using Setel
  - b. Setel recognize fuel purchase of more than RM50
  - c. Once payment is done, users will receive a push notification and an inbox message to redeem their e-Voucher.
  - d. Users can go to Rewards > Mydin Voucher > tap on Redeem Now.
  - e. Vouchers will be displayed at My Voucher. Swipe only when ready to use.
  - f. Users will need to swipe the e-Voucher to reveal the barcode when paying.
  - g. Voucher will need to be scanned by the cashier at the counter.



## **5.0 Cashback**

The MYDIN e-Voucher and Setel e-Voucher must be presented at the counter for redemption and cannot be bundled with other ongoing promotions, offers, loyalty programs, e-Vouchers and/or discounts.

## **6.0 Miscellaneous**

1. The MYDIN e-Voucher and Setel e-Voucher are not refundable, exchangeable for cash or e-Vouchers of other redemption.
