**TERMS AND CONDITIONS**

**1.0 Organizer:**

**1.1** PETRONAS Lubricants Marketing (Malaysia) Sdn Bhd (“**PLMMSB**”) is the organizer of this “Servis Ihsan Madani @ PETRONAS AutoExpert” (“**Program**”) in collaboration with Kementerian Perdagangan Dalam Negeri dan Sara Hidup (“**KPDN**”).

**1.2** The following terms and conditions apply in respect of this Program. By participating in this Program, you agree to be bound by these terms and conditions, including any term which may be amended from time to time, without limitation or qualification.

**2.0 Eligibility:**

**2.1** The Program is open to all Malaysians including:

- (i) permanent/contract employees of PLMMSB, inclusive of their immediate family members, specifically their respective fathers, mothers, spouses, children; and

Hereinafter referred to as “**Participant**” or “**Participants**”.

**2.2** In the event a Participant is found to be ineligible at any point of time during or after the Program Period (as defined in Clause 4), PLMMSB reserves the right, at its sole discretion, to disqualify the said Participant and to cancel, withdraw and/or recall the program to the Participant. - 5.5** PLMMSB may advise PETRONAS AutoExpert outlet to reject any appointment made if there is any non-compliance by any Participant of any of the terms and conditions.
- 5.6** PLMMSB reserves the right to cancel, shorten, extend, suspend, and/or terminate the Program at any time prior to the expiry of the Program Period without prior notice to Participants. For the avoidance of doubt, any cancellation, extension, suspension or termination of the Program at any time prior to the expiry of the Program Period shall not entitle Participants to claim any compensation from PLMMSB or PETRONAS AutoExpert outlet for any and all losses or damages suffered or incurred by Participants as a result of the said cancellation, extension, suspension or termination. PLMMSB also reserves the right to amend, modify, delete, or change any of the terms and conditions herein contained at any time at its absolute discretion without prior notice.
